## **REAL ID**

The deadline for the REAL ID has been extended to October 1, 2021. Pennsylvanians will need a REAL ID-compliant driver's license, photo ID card, or another form of federally acceptable identification (such as a valid passport or military ID) to board a domestic commercial flight or enter a federal building or military installation that requires ID.

## **Driver's License/Photo ID Renewals**

Individuals who renewed their license or ID on or before May 10, 2020 will receive a camera card in the mail. These individuals will still need to visit a PennDOT Photo License Center or Driver License Center to obtain an updated photo. When you receive your camera card, take it, along with appropriate identification, to any Photo Center to receive a new digitized driver's license.

Individuals who renew their license or ID beginning May 11, 2020 will receive a new ID using the current photo that exists in their system. No camera cards will be issued to these individuals. The ID's will be mailed within 15 days. The renewal process is complete when customers receive their final ID in the mail.

The following driver license centers reopened with limited services on Saturday, May 16:  
Allison Park Driver and Photo License Center, 1701 Duncan Avenue, Allison Park  
Butler Driver and Photo License Center, 356 Point Plaza, Butler

Hours of operation at the above locations will be Tuesday through Saturday from 8:30 AM to 4:15 PM. Wednesdays and Thursdays between 8:30 AM and 10:30 AM will be designated times for customers 60 years or older.
